## Proposed Bylaw Changes Approved

At the NWMSCA Fall Business meeting on October 9, there was a presentation and discussion of proposed changes to the NWMSCA Bylaws. These changes were approved through majority vote via an electronic ballot, and officially adopted on October 19, 2020. The approved changes reorganize the NWMSCA Governing Board from a 27-member Governing Board, to a 9-member board with several committees. #### **NWMSCA Outstanding Counselor of the Year Award**

The purpose of the award is to recognize a counselor in the Northwest Missouri District for outstanding service achievement.

#### 1. Eligibility for consideration:

- The nominee must be currently employed as a full-time counselor and have completed three consecutive years of counseling service at the level of nomination.
- The nominee must be a NWMSCA and MSCA member.
- The nominee must hold a Master's Degree in Guidance and Counseling and be certified by the State of Missouri.

#### 2. Criteria for recognition:

- The nominee should possess the personal qualities thought to be desirable in a counselor.
- The nominee must have been responsible for innovations in guidance and counseling programs, for providing leadership in the further development of existing guidance and counseling programs, or for performing an outstanding service to the school or community.
- The activities or accomplishments recognized must have taken place within five years prior to the date of presentation.

#### **NWMSCA Outstanding Advocate of the Year Award**

The purpose of the advocate award is to recognize a person or organization whose advocacy of counseling services in a school setting has an impact for counselors on a local, state or national level.

#### 1. Eligibility for consideration:

- Nominee may be a principal, superintendent, school board member, parent, teacher, community leader, or organization who has consistently made a significant contribution to the improvement of guidance and counseling services in the school setting.
- The nominee should <u>not</u> be actively employed as a school counselor.

#### 2. Criteria for recognition:

- Exemplary support of counseling and guidance services.
- Outstanding promotion of counseling and guidance services.
- Implementation of new/additional counseling and guidance services.
- Improvement of existing counseling and guidance services.

#### 3. Procedures for nomination:

- Nominations may be submitted by administrators, counselors, parents, teachers, or community leaders.
- The nominator must submit a nomination packet including:
  - Nomination page
  - Two letters of support: Letters of Support should be concise, but specific, in discussing the nominee's support, promotion, implementation and improvement of counseling services. Please follow the rubric for evaluation criteria.

## Letters of Recommendation: Each letter will be scored separately with total points for each letter as follows.
